BEFORE THE COUNTY LEGISLATIVE BODY FOR UNION COUNTY, TENNESSEE

RESOLUTION TO ADOPT THE PROPERTY TAX FREEZE PROGRAM AS PROVIDED FOR IN 2007 PUBLIC CHAPTER 581

NO. 01 06-20-2023

WHEREAS, Chapter 581 of the Public Acts of 2007, codified in Tennessee Code Annotated, Section 67-5-705, is a local option law which authorizes counties to adopt a property tax freeze program; and

WHEREAS, the Union County Legislative Body has determined that it is in the best interests of Union County that the county adopt the property tax freeze program;

NOW, THEREFORE, BE IT RESOLVED by the County Legislative Body of Union County, meeting this 20th day of June, 2023, that:

SECTION 1. The property tax freeze program as provided for in Chapter 581 of the Public Acts of 2007, codified in Tennessee Code Annotated, Section 67-5-705, is hereby adopted by the County Legislative Body of Union County.

SECTION 2. The property tax freeze program shall be implemented and administered in accordance with Tennessee Code Annotated, Section 67-5-705 and the rules promulgated by the State Board of Equalization through the Division of Property Assessments.

SECTION 3. The County Clerk shall file a copy of this resolution with the Division of Property Assessments within 45 days of its adoption.


