BEFORE THE COUNTY LEGISLATIVE BODY FOR UNION COUNTY, TENNESSEE

RESOLUTION FIXING THE TAX LEVY IN UNION COUNTY

FOR THE FISCAL YEAR BEGINNING JULY 1, 2022

SECTION 1. BE IT RESOLVED, by the county legislative body of Union County, Tennessee, assembled on this 7th day of July 2022 that the combined property tax rate for Union County, Tennessee for the fiscal year beginning July 1, 2022, shall be \$1.5899 on each \$100.00 of taxable property, which is to provide revenue for each of the following funds and otherwise conform to the following levies:

SECTION 2. BE IT FURTHER RESOLVED, that all resolutions of the county legislative body of Union County, Tennessee, which are in conflict with this resolution are hereby repealed
